- The training committee of the organizational member may recommend the trainee theragist on the following criteria, that the trainee:
 - 1. Has shown their good conduct and professional standing with their organisational member.
 - 2. Is aware of and adheres to their organisational member's codes of ethics/practice/conduct.
 - Has completed their coursework to a satisfactory level and demonstrated that they are ready to commence divical work, or have received a relevant certificate of training.
 - Ratains membership of their training or organisational member for the entire duration of UKCP trainee therapist membership.
- 3. Trainee therapist membership constitutes an associate membership of UKCP:
 - 1. They are eligible to be included in a listing by the UKCP as 'UKCP trainee therapist' only.
 - 2. They do not have voting privileges at any UKCP elections.
 - Responsibility for adherence to codes of conduct and complaints processes and any other regulatory responsibilities lie exclusively with the traines therapist's training organisation.
