

# Finance, Risk and Audit Committee Member

The Finance, Risk and Audit Committee (FRAC) is a sub-committee of the UKCP Board of Trustees and undertakes all of its work on the behalf of Trustees. It reports back to the Board, through the Treasurer. The committee is comprised of the UKCP Treasurer, up to 3 UKCP Trustees, co-opted members, the UKCP Finance Manager and other members of the UKCP management team as required.

# **Remit and Function**

The committees main responsibility is to ensure UKCP has effective management and controls of its finances and risk.

The committee's remit and functions include, but are not limited to:

- Reviewing the annual budget presented by the management, ensuring it reflects the strategic direction of UKCP, and recommending it to the Board for approval.
- Recommending the level of the membership fees annually to the Board, in the light of proposals from the management.
- Providing a strategic view (forecast) to enable UKCP to make longer term decisions and develop long term projects.
- Responding to the Board concerning any queries or concerns that may arise.
- Scrutinising the management accounts on a regular basis, and receiving reports on financial performance from the management, to include an assessment of value for money when required.
- Reporting to the Board on the Management Accounts
- Oversight of the UKCP Risk Register
- Scrutinising the Annual Financial Statements and recommending these to the Board for approval together with the Auditors' Report
- Receiving and acting on the Auditors' Report

## Time commitment

- The expected term of office is three years
- The FRAC holds 7 meetings per year, 2 hours in length, which are normally held on Fridays between 11am and 1pm
- Meetings are held remotely by Zoom or in-person at the UKCP Office (in-person meetings will be held when it is safe to do so)
- It is expected that members will make a commitment to attend all meetings each year

## **Expenses**

This is a voluntary unpaid role. Appropriate meeting-related expenses will be reimbursed in line with the UKCP Expense Policy.
